

Contest Rules for “FORAGE BLITZ”

1. RULES

Subject to applicable laws, these rules govern all aspects of the “FORAGE BLITZ” contest.

2. CONTEST DURATION, PARTICIPATION CUT-OFF DATE AND TIME

The contest begins on Thursday, June 15, 2017 at 9:00am, and ends at 8:00pm (Eastern Standard Time) on Friday, September 1, 2017 as the participation cut-off date and time.

3. ELIGIBILITY

This contest is open to all Quebec residents who have reached the age of majority, except for employees of La Coop fédérée, La Coop fédérée business partners, the business responsible for the website, and other companies that are linked to this contest, as well as the people with whom they are domiciled.

4. HOW TO PARTICIPATE?

To participate in the “FORAGE BLITZ” contest, the participant must receive a promotional code that will be sent directly by mail. They must then go to the blitz.coop website and enter their last name, first name, email, and promotional code to access the contest. Once the participant clicks on the “participate” button, they will see if they have won an instant prize. All individuals who win a prize must provide proof of residency, and if they fail to do so they will not be able, under any circumstances, to claim their prize. Another draw will then be carried out.

5. AVAILABLE PRIZES

20 winners will be randomly drawn from their promotional codes. Participant entries that are not drawn will be kept automatically for the next draw. However, as soon as a participant is selected at random, their name will be withdrawn for future draws. At the end of the contest, a grand prize will be drawn.

A marketing representative from La Coop fédérée will contact the winners by telephone within 2 business days following the draw. All winners who fail to provide valid proof of residency will not be able, under any circumstances, to claim their prize. Another draw will then be carried out.

The winners must accept the prize as described in the regulations. The prizes are neither exchangeable nor redeemable as cash. Refusing to accept a prize releases La Coop fédérée, its business partners, the business responsible for the website, and other companies that are connected to this contest, from all obligations connected to this prize.

10. DISPUTES
